**COMMUNIQUE**

We, the 418 participants of the 9<sup>th</sup> West African Internet Governance Forum (WAIGF), meeting in Cotonou, from 27<sup>th</sup> to 28<sup>th</sup> July 2017, representing the Internet governance initiatives of the following twelve (12) countries: Benin, Burkina Faso, Cabo Verde, The Gambia, Guinea, Guinea Bissau, Liberia, Niger, Nigeria, Senegal, Sierra Leone and Togo;

With the participation and support of the following partners: ECOWAS Commission, WATRA, UPU, OIF, ABETIC, Agence du Numerique (ADN), FOSSFA, ICANN, AFRINIC, ISOC, Alliance for Affordable Internet (A4AI), IGF Secretariat, APC, ISOCEL, Bel BeSA, ACSIS, and IGFSa.

- Recalling the results of the previous editions of the West African Internet Governance Forum which were held respectively in Accra, Dakar, Lagos, Freetown, Abidjan, Abuja and Niamey;
- Considering the critical importance of the Internet to the economy of countries and the need for greater access to affordable Internet
- Recognising the need ensure user and market confidence to sustainably own the benefits of the Internet at the community level;
- Desirous, on one hand, to build an innovative, dynamic, prosperous, and united sub-regional Internet community and, on the other, a stable and secure Internet ecosystem.

## **1) Report that:**

- a) The transfer of the WAIGF Secretariat from FOSSFA to the ECOWAS Commission has been concluded as directed by the 8th Forum
- b) The WAIGF structure consisting of an advisory committee, a WAIGF secretariat, a coordinator, a planning committee and a resource mobilisation committee, with the involvement of national IGFs is functional.
- c) The 10th Forum shall hold in Burkina Faso in 2018.
- d) The 11th Forum shall hold in The Gambia in 2019.

## **2) Recommend;**

### **a) On Security Openness and Privacy**

- i. Extensive education and sensitisation of users on privacy and security tips for a healthy and secure digital life
- ii. Reinforce the capacity and operation capacities of National CERTs

### **b) On Cyber-security and Trust**

- i. Accelerate cyber-security strategies for each country
- ii. Establish robust child online protection strategies

### **c) On Internet Shutdown**

- i. Endorse and apply the principles of the African Declaration on Internet Rights and Freedoms
- ii. Adopt a «permanent availability of the internet» policy for the community

**d) On Electronic Commerce**

- i. Harness the potentials of the existing community texts and developments and the free movement of goods persons to enhance electronic services in the region.

**e) On Law enforcement**

- i. Encourage the ratification of the Malabo and Budapest Conventions.
- ii. Increase collaboration among security officials in the countries of the region
- iii. Continue the trainings and capacity building initiatives in the region for all Law stakeholders
